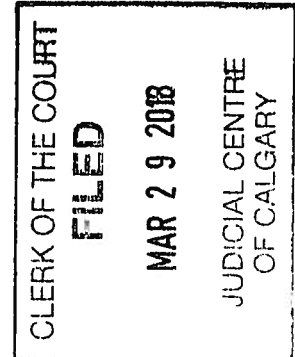

**Basis for this claim:**

1. The Applicant, Sage Properties Corp. (**Sage**) is the owner of certain lands located in Rocky View County and legally described as:

Containing 22.29 Hectares (55.08 Acres) More or Less

(collectively, the **Sage Lands**).

2. Sage obtained the Sage Lands through a court-sanctioned transaction in the within CCAA proceedings (the **Transaction**).

3. The Court Orders in the within proceedings sanctioning and approving the Transaction contain a come-back clause pursuant to which Sage makes the within Application.
4. Immediately adjacent to the Sage Lands is a retirement community comprised of 192 condominium units (**Parcel C**), governed by six (6) condominium plans:
  - (a) Condominium Plan 9812469;
  - (b) Condominium Plan 0011410;
  - (c) Condominium Plan 0013287;
  - (d) Condominium Plan 0111629;
  - (e) Condominium Plan 0113520; and
  - (f) Condominium Plan 0310076.
5. Each Condominium Plan is governed by a duly registered condominium corporation (the **Condominium Corporations**).
6. There are 198 titles registered against Parcel C, legally described as identified in Schedule "B" to this Application.
7. An easement bearing registration number 001 042 374 (**Easement 374**) is registered against Parcel C and the Sage Lands. Pursuant to Easement 374, Sage owns a two-third interest in certain Utilities located on the Sage Lands and Parcel C (as defined in Easement 374) and the condominium owners have a one-third interest in the Utilities (**Parcel C Owners**). Easement 374 stipulates that the Parcel C Owners are required to maintain and operate the Utilities.
8. The Parcel C Owners have not, and never have, maintained or operated the Utilities. Instead, Sage has maintained and operated the Utilities since in or about November 1, 2016. Pursuant to Easement 374, Sage is entitled to full compensation for those costs.

9. A representative for the Parcel C Owners and Sage are attempting to negotiate a replacement Mutual Access Easement Agreement to replace Easements 374 and 372. The proposed Agreement maintains the rights of way created in Easements 374 and 372, while updating and transferring maintenance and operations obligations to Sage to be consistent with existing practice. Doing so would remove the Parcel C Owners' obligations with respect to the maintenance of the Utilities.
10. The deregistration of the Easements would be beneficial to Sage and the Parcel C Owners. It would also benefit the public interest as doing so would permit regulation of the Utilities by the Alberta Utilities Commission, insofar as Sage is applying to the Alberta Utilities Commission in respect of same.
11. The deregistration of the Easements would be just, convenient, and reasonable in the circumstances as it would reflect the Sage Lands and the reality of the use of the Utilities.
12. The deregistration of the Easements would also be consistent with: i) the prevailing law on what constitutes a valid easement; and ii) the implied release of the Easements by the Parcel C Owners.

**Remedy sought:**

13. An Order directing that the Easements bearing Registration Numbers 001 042 374 and 981 274 372 be discharged from the Sage Lands and the Parcel C lands forthwith and replaced with a Mutual Access Easement Agreement, or such other substantively similar agreement, registered against only the common property of the Condominium Corporation;
14. Advice, declaratory relief, and directions as to the ownership of the Utilities;
15. Such further and other remedy as this Honourable Court may deem appropriate.
